R001/21 PUBLIC SPEAKING

R002/21 APOLOGIES AND REASON FOR ABSENCE

R003/21 DECLARATIONS OF INTEREST AND NOTIFICATION OF CHANGES

R004/21 MINUTES OF THE PREVIOUS RECREATION MEETING

It was **RESOLVED** by all present that the minutes of the Recreation and Environment Committee meeting held on 14th December 2021 be accepted as a true and correct record of the meeting. Cllr Knight signed the minutes.

R005/21 CHAIRS UPDATE

Cllr Knight had no announcements to make.

R006/21 ASSISTANT CLERK UPDATE

The Asst Clerk updated as below:

- Solar Lights for the Common have been purchased but due to fixing issues and inclement weather they are still to be put up.
- The Handrail at Charrington Way leading down to the A281 has been reported to WSCC and chased.
- Gate and hard-standing works at Charrington Way have been completed.
- The 2 new bins have been installed at the bus stops by Mulberry Gardens and this news has been shared on Facebook.
- Cllr Knight met with HDC Park's Supervisor at the Common and his report has been circulated to members.
- Cllr Knight approved a fence to be installed at the Ducky pond road end (delegated authority), as noted as a Health and Safety Issue by HDC Park's Supervisor.
- The proposed VE day bench is currently a 6-week delivery once ordered they have no space to hold an order.
- Top Common clearing of vegetation in preparation for Spring/Summers is due to

commence w/c 1st March.

- Cllr Knight authorised Stickers for playparks noting postcode (delegated authority) as recommended by our PSCO.
- Tree Works as noted in the Tree Survey are due to commence w/c 9th March.
- EO has fixed the damaged duck bin but will wait for the ground to dry before putting back in situ.
- Positive feedback from EO regarding Dog-bag dispenser at Charrington Way with little dog mess found and/or discarded bags.
- Litter has increased at the Common with suggested ASB litter EO will monitor this.

MAINTENANCE

R007/21 Fitness Equipment Inspections

It was **AGREED** to bring forward these inspections to Spring/Summer and for Asst Clerk to bring costings of these inspections to the next Recreation Meeting.

R008/21 Surfacing at Ducky Playpark.

The surfacing around the cable-run was discussed.

It was **AGREED** to pick a day for a Village Tidy to be promoted alongside the Great British Spring Clean. This day was **AGREED** to be the 12^{th of} June 2021.

R012/21 Life Buoy

The recommendations made by HDC Parks Supervisor were **NOTED**. It was **AGREED** To purchase and install a Throwline for the Ducky Pond area

(Proposed; TO, Seconded; JC).

It was **AGREED** To proceed with Quote 1 for a basic ecological survey and for Asst Clerk to progress with this survey.
